

NOTES:

- THIS FLOOR PLAN SHOWS A TOTAL OF 17 GAME COURTS. THE COURTS ARE COMPRISED OF THE FOLLOWING COURTS:
 - 1 COMPETITION BASKETBALL COURT
 - 3 PRACTICE BASKETBALL COURTS
 - 4 PRACTICE VOLLEYBALL COURTS
 - 9 BADMINTON COURTS
- TYPICAL GAME COURT LAYOUTS ARE SHOWN ON SHEET C4 FOR EACH COURT TYPE SHOWN ON THE FLOOR PLAN. THEY PROVIDE COURT DIMENSIONAL INFORMATION AND ARE INTENDED TO CLARIFY THE LINE WORK REQUIRED FOR EACH COURT INDICATED ON THE FLOOR PLAN. ALL COURT DIMENSIONS AND CONFIGURATIONS ARE TO BE IN CONFORMANCE WITH THE CURRENT "RULE BOOK" PUBLISHED BY THE NATIONAL FEDERATION OF STATE HIGH SCHOOL ASSOCIATIONS.
- THE FOLLOWING ORDER OF COURT IMPORTANCE AND COURT LINE DOMINANCE SHALL BE ADHERED TO IN PAINTING THE GAME COURTS AS SHOWN ON THE FLOOR PLAN.
 - THE COMPETITION BASKETBALL COURT LINES SHALL DOMINATE ALL OTHER COURT LINES AND THEY WILL INTERRUPT ANY OTHER LINES WHICH APPEAR TO CROSS OR BE COINCIDENT WITH THEM.
 - THE PRACTICE BASKETBALL COURT LINES SHALL DOMINATE THE LINES OF THE PRACTICE VOLLEYBALL COURTS AND BADMINTON COURTS SHALL INTERRUPT THESE LINES WHERE THEY APPEAR TO CROSS OR BE COINCIDENT WITH THEM.
 - THE PRACTICE VOLLEYBALL COURT LINES SHALL DOMINATE THE LINES OF THE BADMINTON COURTS IN A MANNER SIMILAR TO THAT DESCRIBED ABOVE.
- ALL COURTS SHOWN IN THE FLOOR PLAN ARE TO BE LAID OUT FROM COMMON LINES, AND LINES PERPENDICULAR THERETO, BASED ON THE CENTER OF THE EXISTING BASKETBALL RIMS AND THE EXISTING FLOOR BRACKET SLEEVES FOR THE VARIOUS GAME POSTS.
- ALL COURT DIMENSIONS ARE MEASURED TO THE OUTSIDE OF THE COURT LINES, UNLESS OTHERWISE INDICATED.
- COURT STRIPING ON THIS DRAWING DEPICTS YIELDING BREAKS AT INTERSECTING STRIPING IN A CONCEPTUAL MANNER ONLY. GAP BETWEEN DOMINATE AND YIELDING LINES SHALL BE 1/4".
- CONTRACTOR AT END OF PROJECT SHALL PROVIDE ONE (1) QUART OF PAINT OF ALL COLORS USED.

 - (F) FURNISH & INSTALL POST ANCHORS AND SLEEVES PER DETAIL 1/C4 (TOTAL OF 23).
 - (G) CONTRACTOR SHALL FURNISH AND INSTALL SUBFLOORING AND WOOD FLOOR PER DETAILS F/C4 AND G/C4.
 - (H) STAIN WOOD ON FLOORING AREA AS SHOWN. STAIN TO BE APPROXIMATELY 15% DARKER THAN REST OF WOOD FLOORING. PROVIDE SAMPLE FOR APPROVAL BY OWNER.
 - (I) FURNISH & INSTALL POWER AND MICROPHONE ELECTRICAL BOXES PER DETAIL 1/C4
- 15% STAIN ON THE FLOOR.

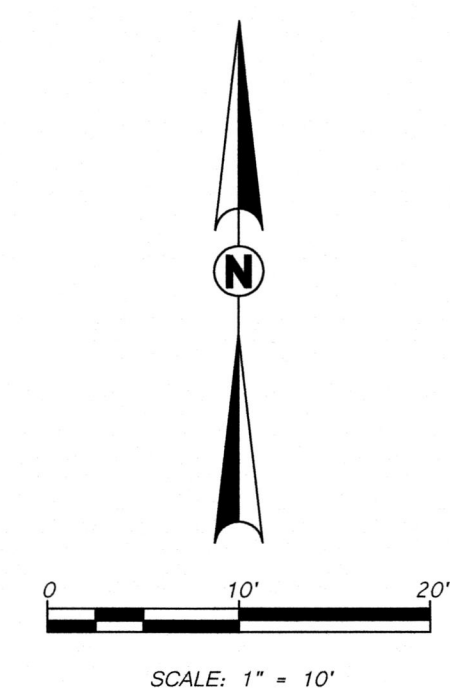
