We work extremely hard at creating a safe and supportive learning environment where students feel safe and excel in Mind, Body, and Spirit. There is power in acknowledging student success, no matter how big or small and in greeting him or her in a friendly manner each day. Our staff understands this and the importance of building positive self-esteem in all our students at Alta Sierra. Alta Sierra Intermediate School is a school with a strong sense of community and service. They are committed to providing students an experience of giving back to their community through philanthropic community-service projects. Each of these experiences teaches our students to take care of themselves, each other, and their community.

Alta Sierra Intermediate School has continued to receive numerous awards and recognitions. Alta Sierra received the Clovis Assessment System for Sustained Improvement (CLASSI) Exemplary School Award for the 2022-23 school year. It also received the California State Pivotal Practices Award in 2021-22; the California State Distinguished School Award in 1996, 2001, and 2005; the National Blue-Ribbon award in 2008; and the California Gold Ribbon School in 2015. Alta Sierra was recognized in the National Schools to Watch program in the spring of 2008 and re-designated in 2011, 2014, 2017, 2020 and 2023. This high honor is awarded only to an outstanding group of schools in the state of California and across the nation. Alta Sierra also received the Fresno State Bonner Award for Civic and Character Education during the 2016-17 and the 2020-21 school years. This award is given to schools that promote core ethical values as the basis of good character and foster an intentional, proactive, and comprehensive approach to core values in all phases of school life. Alta Sierra Intermediate is designated as a Google Certified and a Digital Citizenship School.

Alta Sierra Intermediate utilizes a block schedule that provides teachers and students with extended time, two days a week, to explore concepts, master skills, and infuse critical thinking throughout the learning process. All students are registered for six classes each semester, which consists of five core subjects and an elective. Alta Sierra Intermediate prides itself on the

positive relationships that are developed between staff and students, creating a safe and supportive learning environment where students feel safe and excel in Mind, Body, and Spirit. Alta Sierra Intermediate has fully developed Professional Learning Communities. Teachers meet by department twice a week on late start days to collaborate on best practices, analyze student data, address student achievement concerns, or plan instruction based on identified student needs. Additionally, they identify trend data and/or create common assessments that provide required data for monitoring and evaluating student progress toward standards mastery. Alta Sierra Intermediate is an Emerging AVID (Advancement Via Individual Determination) site. They utilize research based AVID instructional WICOR strategies with our students across all content areas. Through a Multi-Tiered System of Intervention, academic, behavior, and social-emotional support is provided to close achievement gaps and provide struggling students with a solid foundation that helps them to be successful at Alta Sierra Intermediate and prepares them for the rigor of high school.

Many of the topics summarized in our School Accountability Report Card are presented in greater detail at our monthly School Assessment Review Team (SART) meetings, School Site Council (SSC) meetings and English Learner Advisory Committee (ELAC), which are open to all Alta Sierra parents. # 2023-24 Quality, Currency, Availability of Textbooks and Other Instructional Materials

Clovis Unified School District sets a high priority upon ensuring there are sufficient textbooks and materials to support the district's instructional program. CUSD Board Policy Number 6161.1 establishes criteria and procedures for the adoption of all textbooks. All K-8 textbooks purchased have been approved by the State Board of Education and adopted by the Clovis Unified Governing Board. Textbooks and instructional materials purchased for grades 9-12 are aligned to the state content standards and adopted by the Clovis Unified Governing Board.

The Department of Supplemental Services continues to support the school sites with funding that allows for the purchase of supplementary instructional material for our students, including English learners in grades K-12. The supplemental material is designed to accelerate pupils as rapidly as possible toward grade-level proficiency in the core subjects of English-language arts, math, social science and science. These supplemental materials are used in addition to the basic reading/language arts and other core materials provided for every student and are correlated to state content standards.

# 2023-24 School Safety Plan

Alta Sierra Intermediate has a School Safety Plan and a School Crisis Intervention Plan on file, and both are available to all parents and the general public. Staff, parents and the community review and update the school plans on an annual basis. Most recently, the plan was updated in December 2023. The staff develops both plans with input from parents and community members to ensure a safe and nonviolent environment. The School Safety Plan includes information on communication with outside organizations, police and fire protection. It also includes response to school crises; loss of a faculty member or student; as well as safety drills, including evacuation, facility alert, lock down, earthquake, and power outages, which are practiced on a monthly basis. Lessons are conducted annually in classrooms by the administration team discussing school rules, climate and goals with students, as well as expected student behavior.

The categorical programs included in the application are Title I, Part A - Improving Academic Achievement. Title II, Part A - Supporting Effective Instruction and Title III - English Learner (EL), and Immigrant Programs and Title IV, Part A - Student Support and Academic Enrichment. Essentially, these funds are designed to assist students in mastering state standards. Clovis Unified Schools are committed to establishing a true partnership with all facets of the Clovis Learning Community. CUSD values feedback and input. Parents continue to make positive differences in the lives of the children we all support. We know from research that participation in your child's education will not only bring success to your child but other children in the school. Our parents truly make a difference in the lives of Clovis kids! CUSD is pleased and proud to offer a variety of parent involvement opportunities that improve our overall program. Depending on the type of categorical funding a site may receive, district or school parent councils and committees are required under certain requirements and quidelines. Council (IDAC) Local Control Accountability Plan Public Forums (LCAP) We encourage all parents and guardians to become involved with their child's education at the classroom level, the school-wide level, as well as the district level. Each school's School Plan for Student Achievement (SPSA) describes the school's basic educational program and the categorical supplementary programs/services that are designed to support student achievement. Parental involvement is a necessary and vital part of developing the SPSA as well as our overall program. At the district level, parent committees provide input into each of the site's SPSA. If you would like additional information on any of the District Parent Councils or Committees, please call your child's school. The Principal, Learning Director, or Guidance Instructional Specialist (GIS) would be happy to assist you. Listed below are several parent committees that assist with categorical programs and funding. School Site Council (SSC): All schools that operate a categorical program funded through the consolidated application (ConApp) shall establish a school site council (SSC). The SSC shall develop the content of the SPSA. The SPSA shall be reviewed annually and updated, including proposed expenditure of funds allocated to the school through the ConApp and the local control and accountability plan (LCAP), if any, by the SSC. The SSC is composed of parents, students at the secondary level and school personnel. It is responsible for developing, implementing and evaluating the School Plan for Student Achievement programs. Members serve for two years and are elected by their peers. Parent Advisory Committee (PAC) & School Advisory Committee (SAC): The entirety of the SSC acts as the SAC. The SAC serves as an advisory committee for the purpose of advising schools regarding supplemental education programs and acting as a liaison for their school community. They serve to share information and comments both at the district and site level. These education programs are supplemental education opportunities that provide services to students who are disadvantaged, English learners, foster youth and/or at-risk. The SSC has approved to designate our SSC pursuant to California Education Code (EC) Section 52852 to function as the School Advisory Committee. English Learner Advisory Committee (ELAC): All schools enrolling 21 or more English learners are required to form an ELAC. The ELAC is composed of parents and school personnel. The ELAC advises the principal, staff and SSC regarding services for English learners and assists in the development of the annual survey. Members serve for two years. Each ELAC shall have the opportunity to elect at least one member to the District English Learner Advisory Committee (DELAC). District English Learner Advisory Committee (DELAC): Whenever there are 51 or more EL students in the district, there shall be a functioning District English Learner Advisory Committee (DELAC). It is important that each school site ELAC elect a DELAC representative and arrange to have that representative attend every DELAC meeting. Currently the DELAC bylaws require each DELAC representative to be 1) a parent/guardian of an EL or former EL (i.e., a reclassified fluent English proficient student) currently enrolled at the site he/she represents, and 2) elected to serve as the DELAC representative by the site's ELAC. District Indian Education Parent Advisory Committee (IPAC): The CUSD Native American Indian Education Parent Advisory Committee meets four times a year to discuss program issues, services provided, and other needs related to the student achievement of our students, community agencies and outreach programs. CUSD Indian Education Program addresses the needs of American Indian and Alaskan Native students in grades K - 12. The program assists eligible students to achieve at the same challenging state performance standards expected of all students in grades pre-K -12. Local Control Accountability Plan (LCAP) Forums: CUSD develops an LCAP annually that works to better align the academic plan with the district expenditure plan that is approved by our CUSD Governing Board each June. Parents and other stakeholder groups are invited to participate in the development of the LCAP through participation of school and district committee meetings and community forums. LCAP School, District Meetings and Community Forums are exciting opportunities for all stakeholders and school committees to engage with the District and share their ideas on how CUSD can provide quality opportunities and support for CUSD youth and schools. Community participation and feedback in the forums will inform the District's LCAP's funding priorities over the next several years. These forums are designed to provide an opportunity for school communities to hear about CUSD's current efforts to support youth and families and to provide input and feedback on future plans and opportunities. Sites also have an opportunity to work together in teams to share new ideas to support identified groups and to plan for site engagement and implementation. The following is an overview of the categorical funding and programs in CUSD. These funds are further discussed and outlined in each school's SPSA and at the committee meetings. Rationale General District funds provide support for the District's base/core curriculum program. Some children have special characteristics, not reflective of the general school population, that affect their success in the base/core programs. Some come from economically disadvantaged homes; some are educationally disadvantaged or lack English language proficiency because they have a primary language other than English, Children, such as those described above, require supplemental services and materials not generally provided through the base/core curriculum program. The needs of our children are identified, and supplemental services and materials are planned and targeted to meet their special needs. Categorical funds are to be used to provide the financial support to meet these special needs. Philosophy All CUSD schools offer students with special needs the same kinds of high-quality learning opportunities and access to the core curriculum in all curricular areas. Categorical funds are designed to support additional assistance to help students succeed in the regular classroom program (base/core curriculum) and address any learning gaps. The focus is on the effective utilization of supplementary materials, personnel, and staff development. Staff development activities are used to improve instructional practices and strategies to increase the ability of teachers and other staff to challenge and assist all students to reach their fullest potential. Categorical Program Descriptions 1. After School Safety and Education Funds (ASES): This state-administered funded program is a result of the voter approved Proposition 49; provides three-year grant funding for afterschool programs that align with the core instructional day and have the following components: educational and literacy element (tutoring/ homework assistance); educational enrichment element (Additional program/activities that reinforce what is learned in the core instructional day); and provide a nutritious snack or meal that

conforms to California State Education Code requirements. The purpose of the ASES Program is to create additional educational and recreational opportunities for students within the learning community while providing a safe environment for students. The goals of this program are to: 1) improve academic achievement, and 2) provide enrichment opportunities that reinforce and complement the academic program, 2. Title I, Part A (Improving Academic Achievement): A federal-funded program to provide high-quality opportunities for students in high-poverty schools to meet district and state content and performance standards. 3. Title I, Part A, Title X, Part C, Education for Homeless Children and Youths: Title I, Part A funds provide comparable services to homeless children that assist them to effectively take advantage of educational opportunities as provided to children in schools funded under Title I, Part A. These comparable services shall be provided to homeless children in public and private schools, shelters and other locations where children may live, institutions for neglected children and, where appropriate, local institutions such as local community day school programs. 4. Title II. Part A (Preparing, Training and Recruiting High Quality Teachers and Principals): A federal-funded program focused on teacher and principal training and recruitment programs. 5. Title III (Language Instruction for English Learners (ELs) and Immigrants): A federal-funded program focused on assisting school districts in teaching English to limited English proficient students (English learners) and immigrants and helping these students meet the same challenging State standards required of all other students. Title VI (Indian Education Formula Grant): A federal-funded program focused on helping Native American/Alaskan Native students meet the same challenging state standards required of all other students. The goal of the CUSD staff is to create and maintain the best educational environment possible. This can be accomplished with your support and input. If you have any questions, concerns, or would like to become more involved in the educational process at your school, please contact your school principal. Your school can assist you in learning more about categorical programs. #### **Professional Development**

School site administration and teachers plan and implement effective staff development and curriculum improvement. We are implementing the California State Standards, and our teaching staff is ensuring all students strive toward high, rigorous learning goals. Beginning Teacher Support and Assessment (BTSA) exists to ensure the proper support and training of our new teachers. We continue to offer advanced training in utilizing data to drive instruction coupled with a Professional Learning Community (PLC) approach to all curriculum areas, as well as technology integration, reading strategies, writing across the curriculum, student support services and strategies to focus instruction on the California State Standards.

#### **Professional Development**

Our entire staff continues training in the best practices of a Professional Learning Community, coupled with the California state standards. A schoolwide system for supporting discipline plays a major role in the school's behavior intervention and positive school culture. Through these programs, standards-aligned formative assessment data are gathered, analyzed and used to support all students academically. Our schoolwide system for academic intervention MTSS (Multi-Tiered System of Support) during the school day continues to help all students succeed academically, socially and emotionally.

Professional Learning Community activities and department meetings occur every Tuesday and Wednesday morning during collaboration times. Additionally, "release time" is provided by the school site and district administration to ensure that on-going, meaningful, professional development takes place on a regular basis.

The district focused all professional development activities around five identified needs: first time best instruction, mastery learning, multi-tiered system of supports, implementation of the California Content Standards and NGSS Standards, and cultural relevant understanding.

In the 2023-24 school year, the district dedicated one professional development day for certificated staff. Teachers were offered additional professional development opportunities throughout the year as requested in the areas of curriculum training, utilization of AVID strategies, multi-tiered systems of support, and culturally relevant instructional practices.
