| Proof of residence within the school boundary of Pinedale, Sierra Vista, Tarpey, and Weldon |
| *subject to change INCOME ELIGIBLE: |
| Documentation of monthly income (ALL sources for ALL parents) |
| Regular and Steady Income: Two paycheck stubs within previous 60 days |
| Fluctuating Income: Verification for the last 12 months |
| Self-employed: Two current months profit/loss AND most current income tax return |
