Call to Order Welcome Introductions Approve Agenda Approve Minutes Public Comments	 Robyn Snyder called the meeting to order at 9:04am, welcomed the committee, and reviewed the agenda for the day. Harriet Huggins then did an opener activity with the committee as part of the introductions. Robyn Snyder then asked the parents to review the agenda and then asked for a motion to approve. Motion to approve: Oanh Tran 1st motion, Chelsea – 2nd motion Robyn Snyder asked the parents to review the minutes from the previous meeting and asked for a motion to approve. Approval of minutes from last meeting: 1st. Angela Brown, 2nd France Cordon. Robyn Snyder then asked if there were any public comments and none were brought forward.
 District Information-Robyn Snyder Boundary Changes LCAP Status/Update/Stakeholder Input Review of EL Master Plan Consolidated Application School Plan for Student Achievement (SPSA) 	 Nick Mele from facilities presented about the boundary changes and provided a quick overview of the process and the why for the changes. He advised the committee that they could find all of this information on the website at: https://www.cusd.com/BoundaryChangesTBEC.aspx Nick asked if there were any questions. Oanh Tran asked 'Will the changes impact a student who already attends a Jr high and high school? Mr. Mele advised of the proposal to allow all 10th-12 students to remain and advised of the sibling rule. Heather Faret-Bell asked how the funding would change with the boundary changes and was advised that we would be discussing the budget in future slides. There was further discussion about Title I schools being impacted by the boundary and Mr. Mele advised that they did look at this in the proposals. Sarah Cornelison Heather Faret-Bell asked about EL support and crossing guards. Nick advised that he takes care of facilities, but that Dr. Vue and Robyn Snyder would be discussing budgets. Another committee member noted that their principal said at their SSC meeting it is not a district problem, issue, it is a site problem, issue. Dr. Vue gave an overview of LCAP, LCFF funding, the process of LCAP, and provided some examples. She also answered questions related to how parents might get this information at their school sites—where she advised that principals all received these slides in January to share at their site meetings too,

	 Dr Vue then asked for parents to take a moment to provide some feedback via a thought exchange. Lisa Vuola then presented around multilingual English learners. She shared language census information, supports the district currently has in place and future supports that we are looking to add. Committee members asked about the number of newcomers this year vs last year; inquired about a summer program; and asked if there are resources for parents. Lisa advised on the numbers, informed parents about our summer school options that have been taking place over the past 3 years, and about the parent nights we have hosted. Robyn Snyder then shared about the Consolidated Application and explained the purpose of it, how it helps us with funding. She also explained that it is almost time to apply for this funding for next year and asked for a motion from the SSC to apply for future funding. 1st motion -Heather Faret-Bell, 2nd motion - Quentina Johnson. All were in favor. Robyn Snyder then shared the SPSA process and advised the committee that this should be a topic of conversation on their quarter 3 and 4 SSC agendas and that their feedback is very important as they are part of the approval process.
College and Career Readiness Overview Classroom Visits	 Jeff Hodges then presented on scholarship opportunities, the CAL KIDS initiative, FAFSA, and other college and career opportunities. Harriet Huggins then shared on AVID, why it is important for our students, how it supports our teachers, and explained how the district has expanded it. Mandy Lorenzi asked if there is an opportunity for secondary level teachers for the AVID training? Harriet explained when training is and who can attend.

She then explained that the next item on the agenda was the CTE classroom visits and explained that she understood if parents needed to leave, but advised If they wanted to stay to complete the classroom visits, they were welcome to and she introduced the student tour guides: Addie and Billy.
